In order to ensure both the widest dissemination and protection of material published in the Journal, we ask authors to assign the rights of copyright in the articles they contribute to Oxfam GB, on whose behalf the Journal is published by Taylor & Francis Group Ltd. This enables us to ensure protection against infringement. In consideration of the publication of your Article, you agree to the following:

1. You assign us with full title guarantee all rights of copyright and related rights in your Article. So that there is no doubt, this assignment includes the assignment of rights (i) to publish, reproduce, distribute, display, and store the Article worldwide worldwide in all forms, formats, and media now known or as developed in the future, including print, electronic, and digital forms, (ii) to translate the Article into other languages, create adaptations, summaries, or extracts of the Article and all provisions elaborated in 1(i) above shall apply in these respects, and (iii) to sublicense all such rights to others. For the avoidance of doubt electronic and digital forms shall include, but not be limited to, databases, CD-ROM, and in forms accessible via electronic and digital networks and wireless transmission and communication systems.
2. Our publisher, Taylor & Francis Group Ltd, shall prepare and publish your Article in the Journal. We reserve the right to make such editorial changes as may be necessary to make the Article suitable for publication, or as we reasonably consider necessary to avoid infringing third-party rights or law. We reserve the right not to proceed with publication for whatever reason; in such an instance, copyright in the Article will revert to you.
3. You hereby assert your moral rights to be identified as the author of the Article according to the UK Copyright Designs & Patents Act 1988.
4. You retain the rights set out in the Schedule. These are personal rights and cannot be transferred.
5. You warrant that you have secured the necessary written permission from the appropriate copyright owner or authorities for the reproduction in the Article and in the Journal of any text, illustration, or other material. If you are a UK Crown servant and the Article is written in that capacity, the Article must be submitted for clearance by the Permanent Head of the Department concerned. If you are a US Government employee and the Article is written in that capacity, assignment applies only to the extent allowable by US law. In either case it is the Author's responsibility to make the necessary enquiries and arrangements *before* submission of an article.
6. You warrant that, apart from any such third-party copyright material included in the Article, the Article is your original work, and does not infringe the intellectual property rights of any other person or entity and cannot be construed as plagiarising any other published work. Your further warrant that the Article has not been previously assigned or licensed by you to any third party and without

prejudice to the provisions of Clause 3 above you undertake that the fully reference-linked version of scholarly record will not be published elsewhere without the prior written consent of Oxfam GB.

7. In addition you warrant that the Article contains no statement that is abusive, defamatory, libellous, obscene, fraudulent, nor in any way infringes the rights of others, nor is in any other way unlawful or in violation of applicable laws.
8. You warrant that wherever possible and appropriate, any patient, client, or participant in any research or clinical experiment or study who is mentioned in the Article has given consent to the inclusion of material pertaining to themselves, and that they acknowledge that that they cannot be identified via the Article and that you will not identify them in any way.
9. You warrant that you shall include in the text of the Article appropriate warnings concerning any particular hazards that may be involved in carrying out experiments or procedures described in the Article or involved in instructions, materials, or formulae in the Article, and shall mention explicitly relevant safety precautions, and give, if an accepted code of practice is relevant, a reference to the relevant standard or code.
10. You shall keep us and our affiliates indemnified in full against all loss, damages, injury, costs and expenses (including legal and other professional fees and expenses) awarded against or incurred or paid by us as a result of your breach of the warranties given in this agreement.
10. You undertake that you will include in the text of the Article, or in the biographical details, an appropriate statement should you have a financial interest or benefit arising from the direct applications of your research.
11. If the Article was prepared jointly with other authors, you warrant that you have been authorised by all co-authors to sign this Agreement on their behalf, and to agree on their behalf the order of names in the publication of the Article. You shall notify us in writing of the names of any such co-owners.
12. This Agreement (and any dispute, proceeding, claim, or controversy in relation to it) is subject to English law and the jurisdiction of the Courts of England and Wales. It may only be amended by a document signed by both of us.

## THE SCHEDULE

### In assigning copyright to Oxfam GB, you the rights you personally retain as Author are:

1. the right to be identified as the Author of an article whenever and wherever the Article is published;
2. patent rights, trademark rights, or rights to any process, product, or procedure described in the Article;
3. the right to share with colleagues print or electronic 'pre-prints', i.e. versions of the article created prior to peer review, of an unpublished Article, perhaps in the form and content as originally submitted for publication;
4. the right to post such a 'pre-print' on your own website, or on your institution's intranet, or within the Institutional Repository of your institution or company of employment, on the following condition and with the following acknowledgement with the open URL of your article:

5. the right to post the 'post-print' of the Article following publication in *Development in Practice* as an electronic file on an Author's own website for personal or professional use, or on an Author's internal university, college, or corporate network or intranet, or within an Institutional or Subject Repository, but not for commercial sale or for any systematic external distribution by a third party (e.g. a listserv or database connected to a public access server) provided that you include the following acknowledgement with the open URL of your article:

6. the right to share with colleagues (but not on a commercial or systematic basis) copies of an article in its published form as supplied by Taylor & Francis Group Ltd.
